

RAGECON Attendance Agreement

I, the attendee registering, shall be using the building and grounds of The Nugget Resort Reno on June 24-26, 2022 for the purpose of participating in scheduled events of the convention RAGECON herein referred to as "the activity."

I understand and agree that neither The Nugget Resort Reno or RAGECON LLC, nor its trustees, representatives, employees, or agents may be held liable in any way for any occurrence in connection with the activity, which may result in injury, harm, or other damages to the undersigned and/or guests, invited or not, including items brought to the convention, either personal or specifically for the activity.

As part of the consideration for being allowed to use said facility, building, and grounds, as well as all appliances and fixtures in the activity, I hereby assume all risk in connection with participation in the activity. I understand that the facility furniture and fixtures may be moved and used only with permission of RAGECON Staff and that I will be held responsible for any damage that occurs due to negligence or irresponsibility on my own part. I further release The Nugget Resort Reno and RAGECON LLC, its trustees, employees, agents, or representatives for any damage that may occur while participating in the activity. I further agree to save and hold harmless The Nugget Resort Reno and RAGECON LLC, its trustees, employees, agents, or representatives from any claim by the undersigned attendee, their estates, heirs, or assigns arising out of or participation in any form or fashion in the activity.

I also authorize The Nugget Resort Reno and RAGECON LLC, its employees or agents to render or obtain such emergency medical care or treatment as may be necessary should any injury, harm, or accident occur while participating in the activity.

I grant permission to RAGECON LLC and its agents and employees the irrevocable and unrestricted right to reproduce the photographs and/or video images taken of me, or members of my family, for the purpose of publication, promotion, illustration, advertising, or trade, in any manner or in any medium. I hereby release RAGECON LLC and its legal representatives for all claims and liability relating to said images or video. Furthermore, I grant permission to use my statements that were given during an interview or guest lecture, with or without my name, for the purpose of advertising and publicity without restriction. I waive my right to any compensation.

I further state that I am authorized to accept this agreement; that I understand the terms herein are contractual and not mere recital; and that I have agreed to this document of my own free act and volition by accepting these terms at the time of registration with a digital acknowledgement that I accept as legally binding. I further state and acknowledge that I have fully informed myself of the content of this affirmation and release by reading it before I agreed to it.

As an attendee of RAGECON gaming convention I agree to be respectful of other attendees and RAGECON staff at all times. The Nugget Resort Reno, RAGECON LLC and RAGECON Staff reserve the right to refuse service or ask an attendee to leave the convention at any time without a refund at any time. Possible causes of expulsion from the convention include but are not limited to: fighting, cheating, stealing, breaking any Federal or State laws, breaking any Hotel rules, being disrespectful of RAGECON Staff or Attendees, being overly loud or causing a scene.

For the context of this agreement, "attendee" refers to Paying Attendee, Volunteer, Staff, Vendor, Panelist, Press, Guest, or anyone attending the convention.

No Children under the age of 13 will be left at the convention unattended.

RAGECON Standards and Practices

Please remember we are a family friendly show. RAGECON retains the right to judge if images or art is acceptable or not, regardless of your interpretation.

All items listed below include the following: displays, signs, paraphernalia, clothing, games, jewelry, tattoos, direct verbal communication, and/or implication.

1. Profanity – The gratuitous use of profanity and symbols considered vulgar by contemporary standards is not acceptable. At the sole discretion of RAGECON Staff, such behavior will be prohibited at RAGECON.
2. Violence and Gore – Products depicting lurid scenes of excessive bloodshed, gory or gruesome crimes, depravity, lust, filth, sadism, or masochism, presented editorially or graphically, are unacceptable. Products featuring depictions of unnecessary violence, brutality, physical agony, and gore, including but not limited to, extreme graphic or descriptive scenes presenting cannibalism, decapitation, evisceration, amputation, or other gory injuries, are prohibited.
3. Sexual Themes – Displays containing items and/or sexual themes are not permitted. (Products depicting rape and graphic is prohibited. Products featuring sexual perversion and/or sexual abnormalities are unacceptable.)
4. Nudity – Displays or advertising containing nudity are not acceptable. Degrading or salacious products are unacceptable. (Explicit depictions or facsimiles of reproductive organs are not permitted.)
5. Affliction – Displaying items containing disparaging graphic or editorial references to physical afflictions, handicaps, or deformities is not permitted.
6. Supremacy – Items that depict minority and/or nationalities as inferior to other races is not permitted.
7. Religion and Mythology – Actual, current religions are not to be depicted, ridiculed, or attacked in any way that promotes disrespect. Ancient or mythological religions, such as those prevalent in ancient Greece, Roman, and Norse societies, may be portrayed in their historic roles. Satanic symbols, rituals, and phrases are not permitted.
8. Unacceptable Activities – Actual rituals (spells, incantations, sacrifices, etc.), weapon designing, the use of illegal devices, and activities of a criminal or distasteful nature is prohibited.
9. Addictions – Addictions of any kind should not be presented as glamorous or entertaining. Addiction or the encouragement of addiction should be shown as a dangerous habit with harmful effects.
10. Wearing and Selling Costumes or Weapons – Costumes are permitted if they are in good taste and do not present a hazard to others such as sharp edges or protrusions (As determined by the RAGECON Staff). All twentieth century uniforms are prohibited from the convention. Uniforms of those currently on active duty in the military are exempt, assuming they are properly attired. No one may carry weapons or weapon replicas. All cosplay and costumed attendees must be approved at registration prior to entry.
11. Compliance – All attendees are obligated to comply with these standards. Failure to comply will result in immediate expulsion from the convention, and possibly future conventions, with no refund.
